Also, those individuals that have been adjudicated an incompetent. I have enclosed a list of your county's data reported through January 1999. **** OCA RECORDS NOW HAVE AN INDICATOR FIELD (CODE). **** P = convicted felons that are currently incarcerated. M = adjudicated incompetents

The NYSDMV driver's license surrender information reflects surrenders reported through February 1999.

The NYSDOH death certificate information reflects additional death certificates reported through July 1998.

Dear Mr. Wilkey:

January 1996, the Office of Court Administration began providing you with data, via tape, that included two types of defendants. Those who were convicted of a felony and sentenced to imprisonment and those declared incompetent.

In 1997, we sent you information pertaining to a Mr. Kevin Saunders whose case was processed in the Tompkins County Court. It has recently been brought to our attention that this information was sent to you in error. Mr. Saunders was <u>not</u> adjudicated as incompetent. We understand that his voter's registration has been canceled based on the information you received from the Office of Court Administration. We would appreciate you correcting your records as soon as possible so that Mr. Saunders can have his voter's registration reinstated.

I have reviewed the issue raised in the 6th Judicial District regarding reporting to the Board of Elections of individuals that the courts have declared incompetent. Defendants who, following a plea or verdict, have been found not responsible by reason of mental disease or defect, should be reported to the Board of Elections (in accordance with the system we have developed under section 5-708 of the Election Law) only if they have also been committed to the custody of Mental Hygeine (which is now entitled Mental Health). A finding of not responsible by mental disease or defect relates only to the mental condition of the defendant at the time of the crime, whereas such a finding followed by a commitment to the custody of Mental Hygiene necessarily means that the court determined that the defendant was mentally ill as well at the time the plea or verdict was rendered.

A situation has developed in one of our courts which you should be aware of. A defendant entered a plea of "not responsible by reason of mental disease" which was reported to OCA under code "PNR". Thereafter, OCA provided the State Board of Elections with information which resulted in the defendant's voting rights being revoked because their interpretation of the PNR code was that the defendant had been found incompetent by the court.

We have confirmed with counsel's office that a PNR is <u>not</u> a finding of incompetency <u>unless</u> the defendant has also been committed to the custody of Mental Hygiene (now known as Mental Health).

In order to provide for the proper reporting of these matters it will probably be necessary to add another disposition code which covers true findings of incompetency. We are working with OCA to resolve this issue and hope to have a solution in the near future. I assume these dispositions are few and far between but I wanted to alert you to the problem and ask that you refrain from reporting any dispositions of this type to OCA until we have received further instructions.
