The patient remains delusional and psychotic. "All I know is there is \$45,000 waiting for me from the Federal Government and I haven't been seen twice within a 48 hour period. By law, you can't evaluate me now. You have to release me." I try to remind her that Dr. Rahman did attempt to interview her over the weekend but she dismisses this, stating "The picture on his ID didn't match his face. He was a fake." The patient is uncooperative with no insight. In fact, she has refused both group participation and medication since arrival on the unit several days ago.
