FINDINGS:

Image quality is compromised due to the relative inferiority of a portable chest x-ray.

The heart and mediastinum exhibit normal size and contour.

The lungs are grossly clear. There is no evidence of a large pleural effusion.

There is a nondisplaced fracture of the lateral left ninth rib.

IMPRESSION:

- 1. Minimally displaced fracture involving the lateral left ninth rib.
- 2. Otherwise no radiographic evidence for acute cardiopulmonary abnormality on this portable chest x-ray.
