Indication: Sudden drop in hematocrit level.

Contrast: Administered 100.0 ml of OMNIPAQUE 300 mg/ml

CT of the abdomen and pelvis was performed after IV contrast administration. No oral contrast was administered. Coronal and sagittal reconstructed images were obtained.

The lung bases demonstrate bibasilar atelectasis. The heart demonstrates no pericardial effusion. Left chest wall hematoma is noted.

The liver is normal in size. There are several low density lesions in the liver in the medial segment of left lobe measuring 11 mm, inferior tip of the right lobe measuring 5 mm and inferior tip posterior right lobe measuring 5 mm. These may represent small cysts or hemangiomas. No perihepatic fluid is noted. The pancreas demonstrates no mass or pancreatic duct dilatation. The spleen is normal in size. No adrenal masses are noted. The kidneys demonstrate symmetric nephrograms without focal lesions. The gallbladder demonstrates no calcified gallstones, pericholecystic fluid or wall thickening. Common duct is not dilated.

Aorta and inferior vena cava are unremarkable. Atherosclerotic aorta without aneurysmal dilatation is noted. No retroperitoneal hematoma is noted.

The urinary bladder is markedly distended. The prostate is otherwise unremarkable. No hernias are noted. There is no free fluid in the pelvis. No pelvic hematoma is noted. Small bowel and colon demonstrates no abnormal dilatation.

IMPRESSION: Left chest wall hematoma.

Likely hepatic cysts or hemangiomas.

Dependent changes in the lung fields.

No retroperitoneal or intraperitoneal hematoma is noted.
