 INDICATION:
 Fracture dislocation left shoulder.

COMPARISON: Correlation is made with a prior x-ray study of the left shoulder obtained earlier today.

TECHNIQUE: Contiguous axial sections were obtained of the left shoulder. Images were reconstructed in the sagittal and coronal planes.

FINDINGS: There is anterior subcoracoid dislocation of the humerus. There is a fracture defect present along the superior lateral aspect of the humeral head most consistent with a Hill-Sachs fracture. There are multiple small fracture fragments adjacent to the posterior superior aspect of the glenoid process of the scapula which appear to arise from the humeral head fracture. The scapula appears intact. No Bankart lesion is seen.

There is increased soft tissue density present in the left axilla and extending inferiorly along the lateral aspect of the left chest wall most consistent with moderate size contusion and hematoma. There are also a few small bubbles of air within the deltoid muscle possibly from an injection. Recommend clinical correlation.

IMPRESSION:

 ANTERIOR SUBCORACOID DISLOCATION OF THE HUMERAL HEAD.
 HILL-SACHS FRACTURE OF THE HUMERUS WITH MULTIPLE SMALL DISPLACED FRACTURE FRAGMENTS AS DESCRIBED.
 CONTUSION AND HEMATOMA IN THE LEFT AXILLA AND ALONG THE LEFT LATERAL CHEST WALL.
 THERE ARE SEVERAL SMALL BUBBLES OF AIR WITHIN THE LATERAL ASPECT OF THE DELTOID MUSCLE DESCRIPTION AND AND AND RECOMMEND CUNICAL CORDECT ATION.

POSSIBLY FROM AN INJECTION. RECOMMEND CLINICAL CORRELATION.
