COMPARISON: There are no prior studies available for comparison.

TECHNIQUE: Contiguous axial sections were obtained from the skull base through the T2 vertebra. Images were reconstructed in the sagittal and coronal planes.

FINDINGS:

VERTEBRA: The vertebra are in normal alignment. No prevertebral soft tissue swelling or fracture is seen.

C2-C3: No significant disc bulge or herniation is noted. No spinal canal or neural foraminal narrowing is seen.

C3-C4: There is mild posterior uncinate process spurring. No significant spinal canal narrowing is seen. There is mild bilateral neural foraminal narrowing.

C4-C5: There is mild posterior uncinate process spurring and hypertrophic changes within the facet joints. No significant spinal canal narrowing is present. There is mild bilateral neural foraminal narrowing.

C5-C6: There is mild posterior uncinate process spurring and disc space narrowing. No significant spinal canal narrowing is present. There is mild to moderate bilateral neural foraminal narrowing.

C6-C7: No significant disc bulge or herniation is noted. No spinal canal or neural foraminal narrowing is seen.

LUNG APICES: The lung apices appear clear.

IMPRESSION: 1. NO EVIDENCE FOR FRACTURE OR SUBLUXATION. 2. MILD TO MODERATE CERVICAL SPONDYLOSIS AS DESCRIBED.
