Anne Rose has been reluctantly taking oral paliperidone over the weekend in an attempt to stave off the judge's order for Invega Sustenna, which is included in the T.O.O. list and medically indicated for her treatment. I have let her know that this medication is essential for her health and discharge status and that she cannot refuse per Judge Miller's order. Anne Rose responds by becoming agitated and paranoid, questioning the legal validity of the judge's order, as well as the medical credentials of the treatment team members. She comes out of her room to accuse me in front of staff members of being "a psychopath." She does seem much more social, however, going to groups and ambulating without evidence of discomfort on the unit.

**Clinical Impression:** 

62 y.o. single, white, male to female transgendered patient with a history of chronic psychotic and personality disorders, who is transferred from the Hospitalist service following an altercation with law enforcement at a local Denny's restaurant in which she was struck in the face, resulting in nasal fracture, elevated WBCs and elevated CPK. The patient was agitated and combative in the ER, requiring stat administration of IM lorazepam, ziprasidone and ketamine, as well as mechanical restraint for patient's and others' safety. She since required involuntary surgery to reduce a separated left shoulder, after refusing this. On exam she is delusional, angry and hostile.


