DESCRIPTION OF PROCEDURE: After the colonoscopy procedure including risks, benefits, and alternatives not limited to perforation, surgery, and/or death were explained to the patient, written consent was then obtained, no IV medication was given per the patient's request. An Olympus colonoscope was then inserted into the patient's rectum and advanced very carefully through the entirety of the colon and into the distal terminal ileum. Distal few centimeters of terminal ileal mucosa were unremarkable. Photographs were taken. The scope was then withdrawn in a very careful manner over the next 11 minutes through the remainder of the colon. In total, 2 colorectal polyps were seen, both were seen at 20 cm from the anal verge, 1 removed with snare polypectomy, the other removed with jumbo biopsy forceps. Adequate hemostasis was achieved. There were separate polyps, placed in the same specimen container. The scope was withdrawn into the rectum, where retroflexion maneuver was performed. It was unremarkable. The scope was withdrawn from the patient. She tolerated the procedure well, was returned to the recovery room in stable condition.

IMPRESSION:

- 1. Complete colonoscopy into the terminal ileum with snare polypectomy and biopsy polypectomy.
- 2. Two colorectal polyps, status post snare polypectomy of one, biopsy polypectomy of the other.
- 3. I will follow up on all the polyps, report back to the patient at that time. If either one of them are precancerous, she will need a repeat colonoscopy in 5 years from now.
