Dear Judge Greener:

Please note firstly that I yield client-attorney privilege to Mr. Berry, so that he may feel free to augment the tidal wave of *angst* surrounding my case as he sees fit.

Secondly that I also feel constrained in presenting admissions into evidence placed under seal by Judge Miller, other than the photo, shown here prefacing Exhibit B, of the submissions in Evidence and Informations I offered to the Court while acting as attorney *pro se* along with collateral material I shared with Kristine Shaw Esq. after she assumed the role of my defense attorney in September 2019.

Mr. Berry was fired for cause for reasons outlined in my letter of dismissal dated May 16 2019 (see 03: Exhibit C). Epic levels of condescension were displayed all around in court during the proceedings associated with Tompkins IND 03865-18, with that towards me based on what I perceived as an inability to move beyond a kind of "presumption of incompetence," where my acquittal in July 1997 on charges of Arson as Not Responsible due to Mental Disease or Defect (Tompkins IND 97-0019) tends to cast a noxious halo about perceptions of my mental health, perceptions sometimes harshly colored by outrageous "histories" of the events of my life and hostile character analyses subsequently prepared by clinicians employed by New York State's Office of Mental Health obsessed with asserting *guilt* in the arson of 1997 rather than accepting the Court's verdict of *insanity*.

Mr. Berry represents my case from September 19 2018 as one that involved "serious misdemeanour charges," which reflects his failure to grasp that G.I. Herz and John Joly of the Ithaca

Police Department, with the assistance of Clifford Ehmke MD of the Behavioral Services Unit at the Cayuga Medical Center, engaged in felonious conduct including not merely Assault in the 1st Degree (NYS PEN 120.10) but also Deprivation of Rights Under Color of Law (USC Title 18 242) by promoting a false narrative of "mental illness" on my part - accompanied by copious lying on their part - to fly under the radar of review by competent authorities (e.g., the FBI). The assertions I was uttering rambling, incoherent speech by Herz and Joly are belied by other evidence, for example the evaluation performed by Bangs Ambulance personnel as I was transported to the Emergency Department subsequent to the assault (see 04: Exhibit D).

My pleas in court to the charges of Trespassing, Obstruction of Government Authority 2nd, and Resisting Arrest were Not Guilty, Not Guilty, and Not Guilty, and there was not one iota of guilt on my part related to any of these charges; note especially that the initial allegation made by Amanda Rojas, the Assistant Manager of Denny's, that I had skipped on a bill and was disruptive at Denny's the evening before on September 18 2018 was *provably* false, and that I was never once told I was unwelcome at Denny's until Ofc. Herz informed me that was the case around 3:50AM the morning of the 19th - AFTER I had been served breakfast by staff around 3:20AM, a fact omitted from their statements to the IPD?

In sum, assertions that I was dangerous to self or others on account of mental illness on September 19 2018 constitute a smokescreen around barbaric acts of savagery visited upon my person in massive abuses of authority constituting "a shock to the conscience," especially the fog of perjured testimony offered in court before Judge Scott A. Miller by Clifford Ehmke MD on October 5 2018 in support of the hospital's filing for Treatment Over Objection in Tompkins IND 2018-0315.
