PEMS critique (Psycho-Educational Model) 11

- Point scoring equates good & bad behaviors & resolves into a single point score as if good & evil are commensurable.
- "Treatment Skills" are oversimplified, emphasizing rote responses/interactions over more nuanced interpersonal relations - card keeping is an

[Irony: Demonstrations of advanced skills may score fewer points than "target" skills]

intrusion into the flow of normal interaction, adding time multiples x5, extrinsic motivation, "card sharing"

PEMS critique

- Cards are cumbersome, subject to theft & forgery - Chits managed by staff would be more efficient: 3x5 form initials, points
- Group participation should get more points (No preformal)
- Negatives should count separately
- Points should ALWAYS be given for "Treatment skills" - but aren't
- Loss of level privileges to "Basic" is punitive
