A patient, Julia [Session]? She identified herself to me as "Julia Prison" earlier!?) and I were in the entry hallway of the BSU-2N, and we were both upset at our treatment; she had suffered allergic reactions, visible as hives on her face, and I had NOT received the cart hearing I requested on Dec 25 2016, which was MANDATORY within FIVE DAYS of my request. We were both somewhat loud; I retreated into my room ^{as requested, per} and tried to ~~sing~~ guide staff I would calm down if they would leave me alone, but they persisted in harassing me, and after I refused a pill, FORCIBLY SUBJECTED me to shots which have left me with pain in my right leg — Gazeleyk 1/30/17

Alison, Social Worker, informed me that the current Discharge Plan would require me to obtain services from Tompkins County Mental Health. I expressed willing acquiescence, and that I had been happy with the services provided by Linda Riley LMHC, who had been my therapist — she was happy because she knew Linda personally!

John Cottrell RN then told me other part of the plan, involving injection of Sustenna, the long-term ^{substituting} shot for Invega, on which I am currently, and which leaves me sleepy and cognitively mildly impaired due to memory flaws. I expressed my outrage — loudly, condemning this as abuse.

Dr. Clifford Ehardt then told me on encountering me in the hall that I "needed the Sustenna onboard for release," and asked why I am always so upset when dealing with him. I expressed again my facts of the matter, that I came in on a Beings ambulance
