The patient remains poorly organized and hyperverbal, although she is less irritable and does tolerate an interaction with this clinician, if only to berate me about her status as a computer programmer for the government and her sensitive intelligence efforts against criminal hacking organizations. The patient insists that the ziprasidone is making her worse. She specifically complains of nightmares, headaches and restlessness. This is contradicted by observations from myself and other staff members that she has been sitting calmly, reading books and socializing with peers. I am informed by staff that Anne requested and received a print out of the side effects of ziprasidone and started reporting them and mimicking their effects immediately afterwards.
